

Adventure Kitesurfing Academy

Terms and Conditions

1. All courses are booked for specified dates and are non-transferable. All courses are to be paid in full upon booking. No course booking is confirmed until payment of the course is received.
2. The student may cancel the booking at any time up to 28 days prior the course start date by giving written notice to Adventure Kitesurfing Academy where upon a refund will be returned to the student less an administrative charge of £25.
3. Adventure Kitesurfing Academy will provide tuition and all the equipment required for the student to undertake the course. A student can use their own equipment as long it is suitable for the course.
4. The student must accept that all courses are weather dependent and this may adversely affect your course.
5. If in judgement of Adventure Kitesurfing Academy a course is unable to start due to the weather conditions, or because safety could be compromised for any reason, students will be offered a voucher in respect of any days owed to by Adventure Kitesurfing Academy. It is then the responsibility of the student to contact Adventure kitesurfing Academy within 3 months to re-arrange their booking. No refunds will be paid.
6. In the event of a course that has started, being abandoned through unforeseen circumstances, students will be offered where possible the following –
 - 6.1. On a day course where a half-day is lost, a half day will be offered on a future course that has unfilled places. A part course infill does not have priority over a full course place.
 - 6.2. On a part completed two-day course (day and a half or less) an infill will be offered on a future course that has unfilled places. A part course infill does not have priority over a full course place.
 - 6.3. On a part completed three-day course (day and a half or less) an infill will be offered on a future course that has unfilled places. A part course infill does not have priority over a full course place.
 - 6.4. On a part completed private tuition hours owed will be offered on a future date. A part private tuition infill does not have priority over pre-booked private tuition.
7. Students will be notified as soon as possible when infill places become available. There will be no refund of any part of the course cost.
8. All infill places will only be available 48hrs before the course commencement date and the student must contact Adventure Kitesurfing Academy to book an infill place. A three month time limit applies.
9. All decisions regarding the running or cancellation of any course are at the absolute discretion of Adventure Kitesurfing Academy whose decision shall be final.
10. **STUDENTS MUST BE AWARE THAT POWER KITE SPORTS ARE POTENTIALLY DANGEROUS AND ARE UNDERTAKEN ENTIRELY AT THE STUDENT'S OWN RISK.**
11. Upon completion of booking a course or private tuition by the student confirms that he/she has read and understood these booking conditions and accepts the same.
12. Students are required to complete the Release of Liability, Waiver of Legal Rights and Assumption of Risk form and a medical form to notify Adventure Kitesurfing Academy of any medical condition suffered by them that may be relevant to the activity to be undertaken on the course. All information given will be treated with strict confidentiality.
13. Under 18's are required to have all forms to be signed by a parent or legal guardian.
